

## **Eligibility**

### **Al Aman Fund targets two different types of orphaned youth:**

1. **Boarding orphans:** those who have resided in orphan care centers registered under the Ministry of Social Development throughout most or all of their childhood.
2. **Non-boarding orphans:** those living with a guardian or immediate relative under dire economic circumstances, and who are assisted by orphan support organizations registered under the Ministry of Social Development.  
Given that they meet the following criteria:

### **Non-Boarding Beneficiaries**

#### **General Rules:**

1. Preference is given to orphans who lost their 2 parents.
2. Preference is given to applicants from poverty pockets in the governorates, which are identified by the Department of Statistics and the Ministry of Social Development.
3. Priority is given to beneficiaries of national aid and approved official support funds.
4. The applicant must be identified by one of the charitable organizations accredited by Al Aman Fund within his area of residence.
5. The scholarship is provided for studying a bachelor's degree only, covering registration fees, tuition hours fees, and graduation fees, except in special cases that are studied by the Review and Audit Committee and approved by the General Manager.
6. The applicant must be financially unable to cover his educational expenses according to the procedures and forms determined by Al Aman Fund.
7. Al Aman Fund does not pay educational costs retroactively or compensate beneficiaries for classes that the beneficiary has previously paid.
8. Submission of the grant application must be on Al Aman website within the announced time period.
9. The applicant is fully responsible for the accuracy and correctness of the data that he submits to obtain the grant. In the event that the data and documents submitted are found to be incorrect, Al Aman Fund has the right to take all the measures it

deems appropriate.

10. The applicant must abide by the terms and conditions of the grant.

**Conditions for obtaining the educational scholarship:**

1. The applicant must be between 18-20 years old when submitting the application.
2. The applicant must not be married.
3. The general secondary certificate (Tawjihi) must be Jordanian only, with an average of no less than 75% for applicants from the governorates of Amman, Irbid, and Zarqa, and no less than 65% for other governorates.
4. Applicants from areas of poverty pockets are excluded from item (3) above, provided that the high school average is not less than 65%.
5. The applicant's monthly income should not exceed JOD 1,000 if the he/she holds a family book with his/ her name only.
6. The monthly income of those in the applicant's family book should not exceed JOD 2000.
7. The applicant is excluded from the provisions of Clause (6) if he resides with a member of his extended family other than the mother, father, or siblings, so that the family income is not calculated and he is treated as an individual.
8. To provide documents that confirm the place of residence.
9. The applicant must not have been convicted of a misdemeanor or felony.
10. Not to have obtained any educational scholarship from other parties.
11. Should not have received support from any other party to cover educational expenses.
12. The applicant must have been registered at the university on the competitive system and passed with an average of no less than "good" for the semester for which he applied for the scholarship.
13. The applicant must not have siblings studying at Al Aman's expense, with the exception of a decision from the Review and Audit Committee and approval from the General Manager.
14. Complete all required documents and sign all forms and documents required and approved by Al Aman Fund.

**Documents required to submit an application to benefit from Al Aman Fund's services, and Al Aman Fund has the right to amend them when needed:**

- 1.A certified copy of the high school diploma.
- 2.Transcript of high school grades (Tawjihi) certified by the Jordanian Ministry of Education.
- 3.Acceptance notice from the academic body (university).
- 4.A copy of your personal ID.
- 5.Passport (if any).
- 6.Document / Children of Jordanian women.
- 7.Two (2) recent personal photos.
- 8.A copy of the family book (all pages).
- 9.A copy of the birth certificate.
- 10.A copy of the death certificate (father, mother).
- 11.A recent no-conviction certificate, not exceeding two weeks from the date of submitting the application.
- 12.A document that confirms benefiting from the services of associations concerned with orphans affiliated to the Ministry of Social Development (if any).
- 13.Detailed (university) cumulative mark sheet.
- 14.A copy of the last financial receipt for the institution where the student studies.
- 15.Evidence of a recent student.
- 16.Proof of a recent student for each brother or sister at the university or community college.
- 17.A copy of the lease contract for the tenant (if any).
- 18.Proof of family income according to the form approved by the Al Aman Fund.
